The undersigned acknowledges that ASC shall have the right to refuse to transact business with Customer, to modify or release any and all collateral security, to extend or change time of payment, and to settle or compromise with Customer without notice to the undersigned and without discharging or affecting the liability of the undersigned hereunder. This guarantee is to be a continuing guarantee and the undersigned hereby waives notice of acceptance of this guarantee and presentment, demand, protest, and any notice of non-payment or dishonor. The undersigned shall be liable to principal debtor and not merely as surety and the bankruptcy or any assignment in favor of Creditors of Customer shall not affect the enforceability of this agreement.

Where there is more than one signatory to this agreement, each signatory shall be jointly and severally liable under this agreement.

Titling Basics

In order to title a vehicle, we need the **original** Canadian registration.

Always ensure that the vehicle has been registered in Canada before importing it and the registration is available to you before vehicle leaves province.

RED FLAGS Please note vehicles are not eligible for titling if they are marked “salvage” or “rebuilt”.

Any registrations that are marked as “leased” must come with a signed letter on letterhead from the lessor stating that they release all interest in the vehicle.

“Conditional” registrations do not work for titling purposes.

Registrations are customer responsibility. Getting your registrations to us in a timely matter helps the titling process be more efficient.

Titling dates are 30 days from the time of conformity package sent date. US Goods Returned/Ex USA can be titled as soon as they have crossed.

If your vehicles are floored, please let us know and who it is such as AFC, Nextgear, etc. Please notify your flooring company we are titling and we will contact them.

If you need titles sent out or have any questions, please contact our Title Clerk.
